

FIELD & FOREST RECREATION AREA LLC

Release and Waiver of Liability and Hold Harmless Agreement

For and in consideration of my entry upon and use of the premises known as Field & Forest Recreation Area (herein known as "The Premises") to include the campground, trails and all surrounding land, do hereby covenant and agree as follows:

1. I acknowledge camping and other outside recreational activities have inherent risks and dangers associated therewith. I agree to assume all risks associated with my camping and other recreational activities on the Premises. I acknowledge that the Premises consist in large part of land that is rugged in topography and that the Premises contain many other hazards which may include but not be limited to roadways, highways, trails, streams, and bodies of water. I acknowledge the risks and dangers inherent in such hazards and further acknowledge the risks inherent in the operation of 4x4 vehicles, buggies, and other off-road vehicles including motorcycles on and about the Premises, including guided trail runs and rides that take place off the Premises.
2. I acknowledge and fully understand that I may engage in off-roading and off-road motorcycling and related activities upon the Premises and that such activities involve risk of serious injury, including permanent disability and death, and severe social and economic losses which may result not only from my own acts, omissions or negligence but from the acts, omissions and negligence of others, and further acknowledge that there may be other risks not known to me or reasonably foreseeable at this time.
3. I assume ALL of the foregoing risks, and all other risks, whether known or unknown, that may be present in my entry upon and use of the Premises and areas appurtenant thereto, and accept personal responsibility for the damages or injuries I may sustain to my person or property while upon the Premises, as well as on guided trail runs or rides that take place off the Premises, including permanent disability or death.
4. I hereby agree, for myself and for my heirs, executors, administrators, representatives, successors, and assigns, (herein known as "The Releasees") to release, waive, discharge, indemnify and hold harmless Field & Forest Recreation Area, it's owners, officers, directors, limited and general partners, agents, employees, successors and assigns, from any and all claims, suits, demands, obligations, actions, cause of actions, rights or damages rights or damages, litigation expenses, attorneys fees, costs and expenses, including but not limited to, claims for personal injury, permanent disability, death or property damage arising from or in any way related to my entry upon and use of the Premises or areas appurtenant thereto, including guided trail runs or rides that take place off the Premise.
5. I understand that any fee paid to Field & Forest Recreation Area is considered payment for camping only. The trails on the Premises are merely an optional amenity for campers.

The 2019 Novel Coronavirus (COVID-19) Acknowledgement and Assumption of Risk

1. I am currently not experiencing COVID 19 symptoms nor have I had COVID-19 symptoms in the last 14 days.
2. I have not travelled outside of the United States or in an area under a travel health advisory in the last 14 days. I have not provided care or had close contact with any person with COVID-19 or with any person reasonably suspected of having COVID-19 or with any person who travelled outside of the United States in the last 14 days or with any person who travelled in an area under a travel health advisory in the last 14 days.
3. I represent and warrant to the Releasees that I have not been advised by any US Government, State or Local Board of Health or my doctor to self-isolate due to possible exposure to COVID-19.
4. I am fully aware of the risks and hazards with respect to COVID-19 inherent in my attendance at the Premises and participation in the activities of Field & Forest Recreation Area.
5. I freely and voluntarily agree to assume the risk with respect to COVID-19, including the risk of death, bodily injury or property damage, regardless of severity, that I (or my child/ward) may sustain as a result of my participation in the activities of the Premises.

I HEREBY ASSUME ALL RISKS AND DANGERS AND ALL RESPONSIBILITY FOR ANY LOSSES AND OR DAMAGES ON THE PREMISES OR ON GUIDED TRAIL RUNS OR GUIDED RIDES OFF THE PREMISES. I HAVE READ AND UNDERSTAND THE FOREGOING FULLY AND COMPLETELY AND INDICATE THE SAME BY MY SIGNATURE BELOW. I, THE UNDERSIGNED, AGREE TO ABIDE BY, THE RULES AND REGULATIONS OF FIELD & FOREST RECREATION AREA. I also understand that failure to comply with rules and regulations of Field & Forest Recreation Area may result in expulsion from the property without refund.

The undersigned grants Field & Forest Recreation Area permission to take video and photos of the undersigned and such images may be used by Field & Forest Recreation Area for its website and in other promotional materials. I intend this Release and Waiver of Liability and Hold Harmless Agreement to be enforced in accordance with the laws of the State of New Hampshire, and I intend this document to be as broad and inclusive as permitted by law. If any portion of this document is found to be invalid for any reason, the remainder of the document shall continue to remain in full force and effect and shall continue to be binding.
